Incident	Izabela used the foil she did not register for the whole day 5 which is not fair play. I asked her to retire from the races but I don't think she did

Procedural matters	1. The panel of the International Jury was composed in accordance with RRS N1.4(b). 2. Hearing No. 108 and hearing No. 110 were combined into one hearing in accordance with RRS 63.2(b) since both hearings arose from the same incident. 3. The Technical Committee was represented by Cathy Havenga.
Facts found	1. Upon finishing the second race of the Formula Kite Women's fleet on April 4th and while in the racing area, POL JD16 noticed that POL IS5 used a foil by a brand different than the one she was using on the previous racing days. 2. At that time the two kites were 10 meters apart. 3. Upon coming ashore, after having sailed another 2 races, POL JD16 informed POL IS5, she should retire if she had used unregistered foil. 4. At that time POL JD16 became sure POL IS5 has used unregistered foil. 5. At a later time point, POL JD16 informed POL IS5 of her intention to protest. 6. During the post-racing equipment inspection ashore, the Technical Committee identified that POL IS5 was using an unregistered foil in all four races on April 4th. 7. Upon inspection, Technical Committee member who inspected POL IS5 informed POLIS5 that Technical Committee would not protest POLIS5. 8. Technical Committee member then consulted with other members of the Technical Committee, and 10 minutes later submitted her protest.
Conclusion	1. POL IS5 failed to hail 'Protest' at the first reasonable opportunity, as required by RRS F5.60.2(a)(1). 2. Technical Committee failed to inform POL IS5 of the protest at the first reasonable opportunity as required by RRS F5.60.2(b)(3). 3. Therefore, the protest are invalid under RRS 60.4(a)(1).
